ABOUT WOMEN LAWYERS' ASSOCIATION OF SOUTH AUSTRALIA INCORPORATED

The Women Lawyers' Association of South Australia Incorporated ("WLASA" or "the Association") is a professional association that represents the interests of women legal practitioners across South Australia. WLASA is a constituent body of the national organisation Australian Women Lawyers and its Committee meets once a month. WLASA runs fundraising events for charity as well as making representations to parliament and other bodies on issues that impact upon the status of women in the law and society. WLASA also fosters networking amongst women members of the profession.

Membership of WLASA is open to all practitioners and law students who wish to further the interests of women under the law and women legal practitioners in South Australia.

The following is a synopsis of the key activities regularly undertaken by WLASA:

- consultation with the Chief Justice and State Attorney-General on the appointment of senior counsel and the judiciary in South Australia;
- the submission of reports and papers on proposed law reform(s) which affect women and impact upon the broader justice arena;
- the hosting of regular social and networking events, to provide women with legal backgrounds and women practising in the profession the opportunity to develop valuable contacts and meet likeminded professionals; and
- hosting educational activities including career seminars and information sessions for law students and junior solicitors.

OUR OBJECTIVES

WLASA was founded with a number of objectives in mind.

These objectives include to:

- achieve justice and equality for all women
- further the understanding of, and support for, the legal rights of women
- identify, highlight and eradicate discrimination against women inherent in the legal system
- identify, highlight and eradicate discrimination against women in the community generally
- advance equality for women in the legal profession
- create and enhance awareness of women's contribution to the practice of law
- create and enhance awareness of women's contribution to the development of law
- make recommendations and/or submissions on law reform related matters
- provide a professional and social network for women lawyers
- do all such other things as may be incidental to the attainment of WLASA's objectives
- to fulfil any other objects the members of WLASA may in a General Meeting decide

- providing opportunities for our members to engage with fellow female practitioners including senior practitioners and members of the judiciary

GOVERNANCE STATEMENT

INTRODUCTION

The Women Lawyers' Association of South Australia Incorporated ("WLASA" or "the Association") is incorporated under the Associations Incorporated Act (SA) 1995. The business and affairs of WLASA are overseen and controlled by a Committee ("the Committee"). The Committee comprises of WLASA members elected to office bearer positions, namely, President, Vice President, Treasurer, Secretary and eight other WLASA members elected as general members of the Committee.

WLASA is governed with integrity and in a responsible and accountable manner. The Committee is dedicated in their approach to work continuously to meet the objectives of WLASA and to implement strategies in the pursuit of excellence and providing the best membership value.

The Committee meets eleven times a year for the purposes of overseeing all aspects of WLASA's business plan, its objectives and values. Additionally, the Committee reviews its performance by measuring the outcomes of its events and yearly actions against its objectives and ensuring that it complies with any legal requirement(s).

Twelve meetings of the Committee were held during the period 1 July 2013 - 30 June 2014 including the Strategic Planning Day in February 2014.

MEMBERS' ROLE

The Constitution of WLASA requires that a meeting of full members known as the Annual General Meeting ('AGM') is to be held annually; refer to section 4.7 of the WLASA Constitution.

The purpose of the AGM is to:

- To confirm the minutes of the preceding Annual General Meeting
- To receive the President's report for the previous financial year
- To receive the Treasurer's report and the financial statements for the previous financial year
- To elect or re-elect the Office Bearers and Committee Members who must consent in person or in writing
- To conduct any other business placed on the agenda before the commencement of the meeting

All Full (voting) members of WLASA are advised in advance of the AGM in accordance with the requirements of the Constitution. This notice includes notice of nominations for the election or re-election of office bearers and general members of the Committee. The notice for this year's AGM was distributed to all members via e-mail on 19 June 2014.

WLASA Committee encourages all of its members to attend the AGM.

COMMITTEE COMPOSITION

The names and details of all Committee members in office up to 30 June 2014 are set out in this Annual Report.

The composition of the Committee reflects the broad range of experience, skills and knowledge required to oversee the running of WLASA, its business and affairs.

The Committee is responsible for wide variety of matters including succession planning.

To assist in the execution of its responsibilities, the Committee has established a number of Subcommittees. These Subcommittees operate on a needs basis to fulfil a number of diverse roles.

These roles include:

- To provide specialist knowledge to the Committee on a certain matter(s)
- To review and/or advise the Committee on legislation, policy, best practice

- To organise specific social events and fundraisers
- To manage certain projects outlined in WLASA's business plan
- To make recommendations to the Committee on a range of matters

At the 2013 Planning Day it was decided to define 4 permanent Subcommittees namely:

- Policy Subcommittee
- Education and CPD Subcommittee
- Events Subcommittee
- Membership Subcommittee

Role Descriptions for the specific Subcommittees were developed for the first time this year, and the following role descriptions are attached to this Report ("Attachment A"):

1. President/Vice President
2. Secretary
3. Treasurer
4. Policy Subcommittee
5. Education and CPD Subcommittee
6. Events Subcommittee
7. Membership Subcommittee
8. Website/Social Media Administrator

It is intended that the Role Descriptions will be reviewed annually at the Planning Day for the purposes of continuity, consistency and efficiency of the Committee's activities overall, and to provide information for prospective members and candidates interested in participating in such activities.

COMMUNICATION TO MEMBERS

WLASA aims to ensure that members are informed of all major developments affecting its membership. Information is communicated to members as follows:

Annual Report

WLASA has an annual report that is made available to all members. This report includes relevant information about the operations of WLASA during the year and details of future developments. It also discloses information required by WLASA's rules and policies or by law. A copy of this report can be downloaded from the WLASA website after its Annual General Meeting.

Website

WLASA's website provides up to date information for all members. It includes advance notice of events, articles of interest, policies, information about membership, Committee member profiles and WLASA's member distribution and referral system.

Member E-mails

Regular emails are distributed to members who have submitted their email address to WLASA. Examples of e-mails include advance notices of WLASA events, external events, membership information, membership deals and offers and Scholarship opportunities for members.

Facebook and LinkedIn

The WLASA Facebook page enables us to communicate with members and share information. The information contained on this social media site includes photographs and event notices. The LinkedIn profile is similar but does not to date share photos.

WELCOME and PRESIDENT'S REPORT

Welcome to the Annual Report of WLASA for the financial year 2013/2014.

On behalf of the Committee I would like to thank all of WLASA's members who have attended our functions and contributed to its activities over the previous 12 months. In particular the Committee would like to acknowledge the special contribution that the Hon Margaret Nyland AM continues to make to WLASA as its patron.

It has been another exciting year for the Women Lawyers Association of SA. In late October 2013 we successfully launched our Corporate Membership program, which has gone from strength to strength in its first year. We look forward to continuing to work together with firms in South Australia to progress WLASA's objectives. Adeline Lim has done wonderful work, together with other members of the Committee, in establishing this program. The financial support of these new corporate members has enabled us to improve the quality of the events that we provide to our membership, but more significantly has also increased the visibility of the organisation amongst the profession in South Australia. Corporate membership has enabled us to partner with firms to raise the profile of both WLASA and its objectives. It has also enabled us to make a financial commitment as a sponsor of the upcoming Australian Women Lawyers Conference to be held in Adelaide in October.

In March 2014 we held our first Continuing Professional Education seminar, an Ethics Panel Discussion which was generously hosted by one of our new corporate members, Minter Ellison. Particular thanks are due to Rebecca Sandford for organising and chairing this event.

In May 2014 we again partnered with the Law Society of South Australia to hold the (second) Hon Margaret Nyland AM Long Lunch. The lunch proved to be an even greater success this year, with more than 280 people attending, including many lawyers from our new corporate member firms. We were privileged to have the Hon Michael Kirby AC CMB as our guest speaker, and his Honour spoke both persuasively and entertainingly about the position of women in the legal profession in Australia, as well as providing insight into the position of women in North Korea following his recent commission of inquiry for the United Nations. We also thank Margaret Nyland, who acted as MC, and Lipman Karas, our corporate member sponsor for the event. Particular thanks are also due to Amy Nikolovski, who coordinated the event for WLASA.

Amy Challans, a long standing member of the committee and former secretary of WLASA currently holds the position of President of our parent body, Australian Women Lawyers. I have greatly enjoyed working closely with Amy this year, and look forward to the Australian Women Lawyers Conference which will be held in Adelaide in October 2014.

The Committee of the Association doubles as the Law Society's Women Lawyers Committee, and wearing both these hats our business includes the serious work of consulting and commenting on policy and law reform, as well as providing opportunities for women lawyers to meet and network through our social events. Each year the President of the Association is consulted by the Chief Justice in relation to the appointment of Senior Counsel, an important recognition of women in the profession given that the top jobs at both the Law Society and the Bar Association continue to be overwhelmingly held by men.

I would again like to thank the Committee for their support, which has allowed me to continue in my role as President while on maternity leave and working (very) part time. I owe particular thanks to Vice President Daniella Di Girolamo and Secretary Shelley O'Connell.

The past financial year for the Women Lawyers' Association (SA) Inc ("WLA") was financially successful compared with the previous two years. This is predominantly due to the launch of corporate membership and the growing presence of WLA in South Australia. Although WLA had a greater income, expenditure also increased. The increase in expenditure is due to the development of a new and improved website providing greater functionality and information to WLA members and the greater number of functions held by WLA. WLA would like to sincerely thank its patron Justice Margaret Nyland, founding member FMC Charlotte Kelly, Justice Kevin Nicholson and Maureen MacLaren for their generous donations and ongoing support of WLA.

Although the Margaret Nyland AM Long Lunch does not have a financial impact on WLA, it is an extremely popular event which WLA may be able to profit from in coming years. Between holding the lunch and the launch of corporate membership, WLA was unable to hold other fund raising events however the launch of corporate membership has covered the funds normally received from fund raising events.

WLA's most financially successful venture for 2013/2014 was the launch of corporate membership. We raised \$9,100 from our first year offering of corporate membership and have already received \$5,050 in renewals for the 2014/2015 year. Bank interest was up slightly as a result of WLA having more funds in its account to earn interest.

WLA focused on the launch of corporate membership last year and decided that fund raising for a chosen charity would be a cumbersome workload for the committee. WLA will continue with donating to a chosen charity for the 2014/2015 year and was still able to provide \$300.00 to an Adelaide University Prize Winner in the 2013/2014 year.

WLA held numerous functions in 2013/2014 in the hopes of giving back to its members and increasing our profile. WLA held End of Financial Year Drinks, the Annual General Meeting was a special meeting with a photographer to mark the change to the constitution, Corporate Membership Launch, Christmas Drinks with the Judiciary and a Calendar Launch in February 2014.

WLA had previously reduced its expenditure on functions primarily by Committee Members assisting with catering rather than outsourcing to professional caterers. Over the past year, WLA has balanced the time and effort of Committee Members taking on these responsibilities with some outsourced catering. WLA will continue to endeavour to appropriately distribute these responsibilities.

IT and Graphic Design was a large expenditure item this year as the committee decided that the WLA website, logo and standard documents needed updating in order to successfully launch Corporate Membership.

Expenditure on gifts has increased as has miscellaneous costs. Miscellaneous expenditure consisted of wine purchases, individual photographs of committee members for the website, stationery, lodgement fees and the WLA Committee Christmas meeting. Events which traditionally make a loss include the Christmas Drinks with the Judiciary, the Bar Readers Drinks and the AGM.

AWL Report 2013/2014

The previous financial year (2013/2014) for Australian Women Lawyers' (AWL) has extremely busy with AWL celebrating its 15th anniversary, planning and promoting its National Conference and appointing a new President and Vice President.

During this timeframe AWL held face to face meetings in Melbourne (August 2013) and Adelaide (November 2013).

During 2013/2014 financial year AWL focused strongly on increasing its national profile, being active in the media on a range of key issues impacting upon its members and planning and promoting its national conference. In particular, has AWL actively lobbied State and Territory Law Societies to support the adoption of the recommendations contained in the National Attrition and Reengagement Study (NARS) and has made a range of submissions including a submission endorsed by all of its State and Territory Women Lawyer Association Presidents to the Law Council of Australia on the NARS.

One of the key events hosted by AWL in 2013/2014 was its 15th Anniversary gala dinner at the Grand Hyatt in Melbourne. Approximately 200 guests joined the Hon. Chief Justice of the High Court Robert French and the Hon. Chief Justice of the Family Court of Australia Diana Bryant to mark this milestone. The evening featured an entertaining key note speech from Amanda Vanstone and video messages from its past Presidents who reflected on their achievements during their term as President. The location of the event was chosen in

recognition of the Grand Hyatt being the location of AWL's official launch on 9 September 1997. The night couldn't have been possible without Foley's List and Jacinta Fish Legal Recruitment who sponsored the evening.

During 2013/2014 AWL also released its first electronic version of Themis and launched a range of new resource pages on its website including a dedicated policy section of the website bringing together the publications and submissions of its State and Territory constitutional bodies and a dedicated one stop shop page on the NARS.

During 2013/2014 the President of AWL was invited to provide the key note address at the Lawyers Weekly annual Women in Law Awards in Melbourne, to provide the closing remarks to Michael Kirby's speech at the Margaret Nyland Long Lunch in Adelaide, to launch the AWL conference in Brisbane, attend Foley's List celebration of Women in the Law event in Melbourne and present to the Council of the Law Society of SA on the work being undertaken by AWL.

The AWL president has also commented extensively in the media on a range of key topics related to the objects of AWL including a feature article in the Australian on paid parental leave and key note comments in range of publications on the findings and recommendations of the NARS.

In 2014/2015 AWL looks forward to an exciting and challenging year as it hosts its biennial national conference in Adelaide from the 3-5 October 2014 and lobbies the profession to adopt the LCA recommendations arising from the NARS.
